We are pleased to announce that the bid for additional Cold Climate Jackets through this year's Volunteer Emergency Service Equipment Program has been successful.

We thank CFA for its support for the bid. Though the final amount approved was less than hoped – it is envisaged that the allocated funding will cover up-to an additional 1900 jackets State wide.

VFBV has offered to run the ordering process so that Brigades and Groups can be assured of having the opportunity to order specific sizes relevant to their membership profile.

Order forms are available via the VFBV website, and paper copies have been posted to all Brigade/Group secretaries in the January VFBV Mailout. Completed order forms are due back by 28 February 2019, so please followup with your Brigade/Group secretary ASAP.

VFBV will continue to advocate for additional funding to further increase allocations.

Delivery of the new Jackets are expected late June early July ready for the winter season.

## A NEW YEAR. WHAT WILL **2019 BRING?**

I also look back on the year with a sense of pride and satisfaction that despite the challenging times, VFBV has given volunteers a strong voice and a strong voice when many other voices have been silenced, absent or unheard. I look back on the year with a very clear conscience that VFBV sought tirelessly to educate decision makers about our concerns for the future of CFA and a clear conscience that VFBV operated with integrity, dignity

I receive a constant flow of messages from volunteers and supporters of CFA expressing gratitude for the efforts VFBV and our CFA volunteers over the past year and thankful that there has been a mechanism for volunteers to have a voice even when that voice is speaking against the

and professionalism.

I hear daily from volunteers who feel quite deflated about the future and I have sadly to farewell too many experienced and long serving volunteers.

As I have asked before, rather than throw in the towel just yet, we need to keep focussing on what we do best serving our communities. Until the last knife is taken to CFA let's continue to work to demonstrate the professionalism, capacity and importance of the existing CFA model, continue to show just how progressive CFA is and how vital the current arrangements are for the combined needs of local service delivery and major emergencies.

#### **PUMPER TANKER PROTOTYPE**

The Joint Equipment and Infrastructure Committee is seeking volunteer input into the next generation Pumper-Tanker Prototype being developed by CFA.

The Committee has requested CFA use the same process that was used to develop the new Medium Pumper several years ago, that showcased what is possible with a proactive and collaborative approach to consultation and equipment design.

Recently a small VFBV sub-committee of volunteer subject matter experts was formed and have met face to face with ČFA engineers and designers to workshop the criteria and specifications shortlist for the next prototype Pumper Tanker. The committee is now proactively asking for volunteer input into the design of the appliance.

The desire is to build a prototype appliance that will combine the latest safety features available with today's trucking fleet with the best firefighting equipment available while balancing the needs of the unique operating environment these appliances are designed for.

It is expected that once designed the Prototype Pumper Tanker will be showcased across the state by way of a roadshow for further feedback before final design development and roll-Any suggestions or feedback can be provided to your local

# 2019 VFBV STATE CHAMPIONSHIPS

An increased number of teams so far are entered for the 2019 State Urban Championship next March in Bendigo, including teams from both WA and NSW. A consistent number of teams are entered for the State Urban Junior Championship in Kerang next February.

Entry forms for the 2019 State Rural Championships in April at Bendigo, will be distributed to Brigades and available on VFBV's website early February 2019.

As advised in last month's edition, CFA has proposed combining the State Urban Senior and State Rural Championships in 2020, to be conducted alongside each other on the same weekend at the same location.

VFBV's Rural and Urban state competition committees continue discussions with CFA to work through some of the issues of a combined event, including the timing; location; support for the local Committee; sponsorship; and additional equipment

the Joint Training Committee were pleased to receive an update by CFA that our request for a streamlined training package to cater for Thermal Imaging Cameras in the non-structure environment appears to be progressing well.

Delegates have advocated for this improved training

required.

CFA has committed to providing additional support, both financial and administrative, with the intent to not only enhance and improve the State Championships, but build as a showcase of CFA to the community by increasing participation and attendance.

VFBV's state competition committees see this as a positive move, and would welcome any views or feedback from Brigades or competitors.

By providing a course for the non-structural environment, it is hoped this will assist Brigades access training relevant to their risk profile as well as overcome issues with the current course
