# **Increasing Participation Planned Burning:**

Key achievements to date are as follows:

- A survey of the availability and attitudes of CFA volunteers to planned burning was launched last month and is being extensively promoted by both CFA and Volunteer Fire Brigades Victoria (VFBV);
- Key CFA and DEPI personnel are being consulted on the issues and opportunities for increased involvement in planned burning;
- A gap analysis of the skills, systems and equipment required to support increased participation in planned burning has been completed and is currently being documented;
- A report on the legislative framework as it applies to planned burning has been drafted and is currently being reviewed by the Victorian Government Solicitor's Office; and
- A report on the operational risks associated with planned burning has been drafted and is undergoing internal review.

## Over the coming months:

- The project Steering Committee will meet to discuss the findings of the above review. The Steering Committee includes representation from CFA, DEPI and VFBV.
- Work will commence on a report to Government on the opportunities, barriers, resource implications and strategies to increase CFA involvement in planned burning on private and public land.

The project is on track to deliver a report to Government by the end of 2013.

## **Entries now open for the 2013 Fire Awareness Awards!**
