
Fact Sheet





VFBV is actively supporting volunteers experiencing difficulty after the 2013/14 bushfires. In response to enquiries about assistance for volunteers affected by these fires, we have compiled information about the support currently available from the State Government and other agencies.

State Government grants

The Government announced on 10 February that emergency financial assistance is available for eligible residents in bushfire-affected areas in outer Melbourne, Central, Northern and North-East Victoria, and Gippsland. The Personal Hardship Assistance Program offers:

- Emergency relief assistance up to \$500 per adult and \$250 per child to a maximum of \$1,250 per household for emergency accommodation, food, clothing, or personal items, and personal and financial counselling; and
- Emergency re-establishment assistance up to \$31,050 per household for clean-up, emergency accommodation, repairs, rebuilding and replacing some contents. It is also available to eligible Victorians in extreme hardship whose homes have become uninhabitable.
