# Assistance for volunteers affected by 2015/16 bushfires

VFBV is actively supporting volunteers experiencing difficulty after the 2015/16 bushfires. This Fact Sheet contains information about the support currently available from the State Government and other agencies.

## **State Government grants**

The Government has announced that emergency financial assistance is available for eligible residents in bushfire-affected areas in Macedon Ranges, Mitchell, Murrindindi, Moorabool, City of Ballarat, Indigo, Wodonga, Surf Coast and Colac Otway Shires. The Personal Hardship Assistance Program offers:

- Emergency Relief Assistance, which provides payments of up to \$520 per adult and \$260 per child (up to a maximum of \$1,300 per household) is available to help meet immediate needs, including emergency food, shelter, clothing and personal items.
- Emergency Re-establishment Payments which are available to eligible households, provide up to \$32,500 per household for clean-up, emergency accommodation, repairs, rebuilding (a principal place of residence), and replacing some damaged contents.
